State Dental P.G. Seats (MDS) Allotments-2021 (Round 2, off-line)**

The round 2 (off-line) allotment procedure for various PG Dental course (MDS) for Rajasthan State registered candidates, will be carried out off-line as per the schedule given below:

2.	On-line registration (application) for counseling and information form (application form) filling by the candidates <b>Those who are already registered/applied need not register/apply again. Candidates who did not complete both the parts (Part 1 and Part 2) of the application form (information form) for round 1 may now complete their Part 2 of the application form. Application form (information form) filling is mandatory for allotments. A candidate who does not fill application form (information form) will not be eligible for allotment. Both the parts (Part 1 and Part 2) of the application form (information form) must be filled and completed.</b>	14.10.2021 to 18.10.2021 by 8.00 pm

6.	Verification, Allotment and Joining by Sr. Demonstrator candidates for In-Service Quota (sub quota), (before the Board, 9.00 am sharp at Principal Office, Govt. Dental College, Jaipur) (after registering as per serial 1 and 2)	21.10.2021
7.	Publishing of Seat matrix (including AIQ roll back seats, if any)	21.10.2021
8.	Seat allotment and reporting before the Board at the venue (GDC, Jaipur) At the spot on the same day along with submission of all original document and other documents as listed in instruction booklet	22.10.2021

Completion of all other formalities, deposition of prescribed fee along with tuition fee, at the concerned allotted college <b>Reporting, document checking and verification (including prescribed eligibility criteria) at the allotted college along with printout of allotment letter, all original documents, deposition of prescribed admission fee, required bonds etc. and other documents as listed in instruction booklet</b>	23.10.2021 to 26.10.2021 by 5:00 pm
10.	Commencement of academic session	18.10.2021 (As per DCI)

For verification, candidate belonging to PwD / Senior Demonstrator category <b>must present personally along with relevant original documents</b> at given place and time.
The candidates are advised to read the instruction booklet, etc. given on the website, very carefully and also visit the websites regularly.
Any candidate opting the seat permitted by the DCI, New Delhi will not be allowed to claim for any change on this ground, except during subsequent allotment depending upon his/her merit and as per preference only.
No separate information shall be sent to individual candidates regarding the allotment etc.
The allotment of the subject and college shall be made strictly on the basis of merit cum preference and in accordance with the rules and directions laid down by Hon'ble Supreme Court of India / Hon'ble High Court, Rajasthan / DCI / Government of Rajasthan and Rajasthan University of Health Sciences, Jaipur.
No resignation will be accepted (from both round 1 as well as round 2 allotted candidates) after at the spot reporting on 22.10.2021 before the Board at the venue (GDC, Jaipur).
The selected candidates will have to report and join at the allotted college as notified in the allotment letter.
At the time of reporting, the candidate must present all the original documents (as given in the instruction booklet available at the website) and accepted resignation from the institution he/she is pursuing studies at present or from the college allotted through any other counseling including All India NEET MDS counseling. Failure to do so will result in disqualification for admission.
<b>Applicable for Govt. colleges -</b> At the time of joining, a separate Bank Guarantee for Rs. 1.5 lacs and Bond for Rs. 3.5 lacs is to be submitted. As per Government order dated 31.03.2017 and 05.04.2017 Senior Demonstrators working in non-clinical subjects will be given priority (in the same Department in which they are working) as per merit of NEET PG-2021.
The norms of reservation of the State Government of Rajasthan will be applicable only for bonafide candidates of the State of Rajasthan. They will have to produce a valid certificate as per State Govt. rules.
Date for second round of counseling will be notified after first round of allotment. Candidates are advised to follow above referred websites and advertisement(s) in newspapers, regularly.
The decision of the NEET PG Admission/Counseling Board-2021 will be final and binding on all the candidates. In case of any dispute, the area of jurisdiction will be Hon'ble Rajasthan High Court only.
